## NEW YORK STATE PUBLIC WORKS LAW - #1

***Commencing July 18, 2008, all Public Works Contracts in excess of \$250,000 will require that all workers be certified as having successfully completed a 10-hour OSHA Safety Training Course.***

Apprentices take this course at the Trade Education Facility, Local #1 during their first year. For journeymen who have not taken the course, the Trade Education Facility, Local #1 will offer three, 3 session classes on Thursday nights from 5:00 p.m. to 9:30 p.m. --

January 10, 17, 24, 2008  
March 13, 20, 27, 2008  
May 15, 22, 29, 2008

## NEW YORK STATE PUBLIC WORKS LAW - #2

***Commencing February 24, 2008 employers on public works jobs must include, on weekly pay stubs, the prevailing wage for the particular classification of work and on each July 1st, notify each worker of the right and where to report prevailing wage violations. The employer shall be liable for a fine up to \$50 for a first violation, \$250 for a second violation and \$500 for subsequent violations.***
