RE: PROJECT LABOR AGREEMENT COVERING DEPARTMENT OF ENVIRONMENTAL
PROTECTION ALTERATION/REPAIR PROJECTS

Dear Sir:

The Building and Construction Trades Council ("BCTC") and New York City's Department of Environmental Protection ("DEP") recently reached an agreement. Below is a **brief summary** of its terms.

WORKFORCE

88% of all workers must be Union members (on contracts of less than \$1 million certified MBE contractors may employ Union members in lesser numbers)

WORK COVERED

Rehabilitation and renovation work performed by DEP on City owned property which predominately involve the renovation, repair or expansion of a City owned building or structure at a water control plant, filtration plant or pumping station in the five boroughs (including JOCS contracts).

DURATION

For contracts bid and let between January 2010 and June 30, 2014

WORK TERMS

- 1) 40-Hour Week at Straight Time (option - four 10-hour days)
- 2) Overtime - 1½ / Sundays and Holidays - Double Time
- 3) Shift Work - 5% Premium
- 4) 8 Holidays (New Years Day, Martin Luther King Day, President's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day and Christmas Day)

WORK TERMS - CONTINUED

- 5) Journeymen to Apprentice Ratio - Maximum permitted by New York State Department of Labor
- 6) Organized Coffee Breaks - None, except when working four 10-hour days
- 7) Meal - ½ Hour at Work Location
- 8) Temporary Services - Only required upon specific request of DEP or Construction Manager
